Summary and Background Information

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

The federal ARP statute requires that States reserve ARP ESSER funds for three State-level reservations for evidence-based activities and interventions that respond to students' social, emotional, mental health, and academic needs and address the disproportionate impact of COVID-19 on students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children and youth in foster care, and migratory students.

Not less than 5 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, activities to address the academic impact of lost instructional time by supporting the implementation of evidence-based interventions.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based summer enrichment programs.

Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based comprehensive after-school programs.

The 2021-2022 enacted New York State budget fully allocated the required SEA reserves as subgrants to 398 LEAs and NYSED has made allocations to two additional LEAs. Specific LEA allocations are detailed in Columns D, E, and F in the <u>ARP ESSER Allocations Chart</u> (see also in the Document Library). Please note that these funds are in addition to the 90% LEA ARP-ESSER ALLOCATION listed in Column C of that workbook and must be budgeted for separately.

All grade levels have a MTSS team that meets regularly to review both academic and social emotional data and observations to help develop plans of intervention, based on student needs. Data from these meetings help us drive instruction and determine who will be placed in summer school, attend after school programming or sessions outside of the school day. Examples of academic sources used to identify students who may need additional services include for K-8 students: iReady, Aims Web Plus, writing samples, and running records. Grades nine-twelve students are continuously assessed with local tests, and common formative assessments. In addition to teacher observations, we are going to be using The DESSA Devereux Student Strengths Assessment 9-12 (self assessment) and K-8 teacher assessment to help us gather data on K-12 students' emotional health. This will help us program for students who may be struggling with social and emotional issues. Finally, we will be able to set up more support groups outside of the school day and during the summer to meet their individual mental health needs.

Our District has historically used Multiple Measures for assessing student needs including but not limited to our elementary literacy profile, New York State English as a Second Language Achievement Test (NYSESLAT), Benchmarking, Common formative assessments that provide information about students' skills, Unit and lesson assessments for ELA, mathematics, science, and social studies. Additionally, our six schools have MTSS teams that meet consistently to review data and other criteria to identify student needs and focus on high quality support and intervention for instruction. Using the additional resources from CRRSA [Reading/Math AIS,SEL staff], ARP-ESSER [Reading/Math/SEL staff], Title I [Reading/Math staff], IDEA and other grant opportunities we will be able to ensure that our students continue to demonstrate growth and close learning gaps.

The LEA will monitor and evaluate the effectiveness of the selected strategies by using benchmark data that takes place three times per year. The benchmark data specifically looks at ELA and Math scores using iReady data scores. In addition, a writing diagnostic is administered three times per year. Our teachers and intervention specialists including the AIS Math and ELA teachers and the teacher assistants will guide their instruction based on data received throughout the year.

Our District has historically used Multiple Measures for assessing student needs including but not limited to our elementary literacy profile, New York State English as a Second Language Achievement Test (NYSESLAT), Benchmarking, Common formative assessments that provide information about students' skills, Unit and lesson assessments for ELA, mathematics, science, and social studies. Additionally, our six schools have MTSS teams that meet consistently to review data and other criteria to identify student needs and focus on high-quality support and intervention for instruction. Using the additional resources from CRRSA [Reading/Math AIS,SEL staff], ARP-ESSER [Reading/Math/SEL staff], Title I [Reading/Math staff], IDEA and other grant opportunities we will be able to ensure that our students continue to demonstrate growth and close learning gaps.

The entirety of the AIS Plan draws additional resources from CRRSA [Reading/Math/SEL staff], ARP-ESSER [Reading/Math/SEL staff], Title I [Reading/Math staff], and IDEA-CCEIS [Reading/Math staff] to maximize high quality direct instruction opportunities within the school day for identified students. 1% State-Level Reserve - Summer Learning and Enrichment: Program Design

Summer learning programs can offer another opportunity to accelerate learning, especially for those students most impacted by disruptions to learning during the school year. Schools and districts should design programs that work best in the local context and reflect the characteristics that evidence suggests lead to successful summer programs. These characteristics include: programs are voluntary, full-day lasting five to six weeks, include three hours of language arts and mathematics taught by a certified teacher each day, and include enrichment activities and experiences. Research points to the potentially positive benefits of strong summer programs. A longitudinal study of summer programs showed students who participated in the summer programs that were reviewed received some benefits in mathematics; however, students with high rates of attendance who attended programs for consecutive summers experienced the greatest learning gains. The amount and quality of instruction influenced the academic benefit, with the highest benefits to students attending programs with high-quality instruction provided by a certified teacher and high academic time on task.

Our District has historically used Multiple Measures for assessing student needs including but not limited to our elementary literacy profile, New York State English as a Second Language Achievement Test (NYSESLAT), Benchmarking, Common formative assessments that provide information about students' skills, Unit and lesson assessments for ELA, mathematics, science, and social studies. Additionally, our four elementary schools have MTSS teams that meet consistently to review data and other criteria to identify student needs and focus on high-quality support and intervention for instruction during the summer months.

The District will operate an Elementary Summer Enrichment Program. Placement in the in-person summer enrichment will be based on data and teacher recommendations. Data will be used to identify students who would benefit from summer support and to group students appropriately. Quantitative data included i-Ready (Math, Reading), AIMSWEB Plus, Running Records, Sight Word Analysis, classroom assessment. Qualitative data included teacher observation and discussion with grade-level team members. Our comprehensive MTSS program helps us to ensure student success and close learning gaps.

Grade Level Gap Skills and Standards will be Identified by grade level teachers and standards leaders and addressed during summer enrichment. The focus of the elementary program will be to provide opportunities for students to catch up, keep up and develop new skills related to the learning standards, and support their social and emotional health.

Students will be supported with current grade-level content, skills, and standards. Center rotations (direct, differentiated instruction with teachers) and access to instructional apps and technology. Further, Integration of recreational, cultural, and enrichment activities and opportunities for movement and physical activity will be highlighted.

Moreover, our district has been able to align and coordinate funds from other initiatives to ensure successful summer programming in the following ways. Our reading specialists and math specialists are supported through the Title 1 funding; Our Academic Intenvion Support teachers are supported by CRSSA, many of our teacher aides are supported through IDEA and our teacher assistants and teachers on special assignments are funded through the ARP grant. All of the above mentioned will support our summer programming to help to ensure successful implementation of data collection and interventions. Our intention is to use small group instruction given by our intervention specialists to allow students to meet the standards for each grade level. It is imperative that we use these plans to reteach grade level standards but also begin to pre-teach the foundational skills necessary for the learners for the next grade level. Learners will be pre and post assessed and instruction will be personalized to ensure foundational standards introduced for anticipated academic success as well as a smooth emotional transition back to school in the fall in the next anticipated grade level. Creative planning and programming using ARP, CRSSA, IDEA and Title 1 will help us achieve successful summer programming and transition back to school for the fall.
