The tests represent one valuable data point that teachers and administrators will use in order to assess school wide performance by standard and skill. It is important to note that we combine the data from these assessments with other student data points in order to fully recognize the strengths and needs of all individual students in order to further plan for instructional support. Student performance on the 3-8 assessments is not linked to teacher and principal evaluation and does not drive placement decisions for students the following year.
